## Grant Eligibility

The National Rowing Foundation, ("NRF") supports organizations assisting athletes who are pursuing excellence in the sport of rowing, with the primary goal of promoting United States' gold medals in international rowing competitions leading up to and including the Olympics and Paralympics. Eligible applicants must use funding strictly toward one or both of the following objectives:

1. Supporting US National Team Athletes in international competition on a pathway to the Olympics and Paralympics.
2. Identifying and developing future US National Team Athletes from historically underrepresented groups.

## Application Process

After having reviewed the above Grant Eligibility criteria, if you feel there is a good fit between your program/organization and the NRF, we strongly encourage you to contact us at [grants@natrowing.org](mailto:grants@natrowing.org) before applying.

The NRF reviews grant applications on a rolling basis. This grant process is competitive. Not all applications will receive funding. Prior to making grant determinations, the NRF may request more information from applicants, potentially including presentations to the NRF Grant Committee. The NRF retains the rights to change or modify the grant application at any time.
